

DOG WALKING CONTRACT

This contract for services between:

“**Owner**” and “**Walker**” agree to enter into this Dog Services Contract (hereinafter referred to as “**Contract**” based on the following provisions:

1. RELATIONSHIPS and RESPONSIBILITIES

1. “**Walker**” shall perform the contracted services in an attentive, reliable and caring manner and “**Owner**” shall provide all information necessary to assist in this performance.
2. “**Walker**” shall supply and be equipped with appropriate equipment including waste bags and shall remove the dog’s feces from all public places during the period in which the dog is in the custody of “**Walker**”.
3. “**Owner**” will provide suitable harnesses, collars and leads as approved by “**Walker**”, as well as identification, coats, or muzzles if required.
4. It is expressly understood that “**Owner**” retains the services of “**Walker**” as a sole proprietor. “**Walker**” shall be responsible for insurance and all statutory declarations and payments to third parties, including federal and local governments.
5. “**Walker**” shall notify “**Owner**” of any occurrences while the dog is in the custody of “**Walker**” which may be relevant to the care and well-being of the dog.
6. “**Walker**” reserves the right to walk “**Owner**’s” dog with other compatible dogs at the same time, and shall limit the number dogs walked in any one group to six (6).

1.7. “**Owner**” acknowledges that “**Walker**” will from time to time need to access “**Owner**’s” home.

1.7.a. “**Owner**” agrees to ensure that access, whether by providing a key, access code, remote control entry or any other device to be retained by “**Walker**” for the duration of the “**Contract**,” or by some other mutually agreed upon means.

1.7.b. “**Walker**” agrees to keep safe and confidential all keys, remote controls, entry devices, access codes and personal information of the Owner and to return same to “**Owner**” upon termination of the “**Contract**.”

8. **“Walker”** shall not be obliged to perform any other duties except those specified in this **“Contract.”**

2. SERVICES

“Owner” and **“Walker”** agree to the following description of services addressed by the **“Contract”**:

A **“walk”** shall consist of the agreed upon duration.

3. DURATION OF CONTRACT

1. 3.1. This **“Contract** shall come into effect on the ____ day of _____, 20____ .
2. 3.2. Either party, **“Owner”** or **“Walker”**, may terminate this **“Contract”** with twenty- four (24) hours notice without incurring charges, penalties, or damages.

4. FEES

1. 4.1. **“Walker”** shall be paid the agreed upon amounts per our stated fees.
2. 4.2 Accepted forms of payment are Cash, Checks, and PayPal.

4.4. Cancellations

4.4.a. Cancellation by **“Owner”** of scheduled walks with less than 24 hours confirmed notice shall be charged at full rate or rescheduled at the discretion of **“Walker”** based on availability.

Confirmation of cancellation will be provided to **“Owner”** by **“Walker”** as

soon as possible after **“Walker”** receives notice of the cancellation by agreed-upon methods of communication previously determined in the Client Pet Profile Form.

4.4.b. Cancellation by **“Walker”** : Should **“Walker”** be required to cancel a scheduled walk due to unforeseen circumstances, **“Walker”** may provide a qualified substitute with the written approval of **“Owner”** and at the same rate as previously agreed to by **“Owner”** and **“Walker.”**

5. EMERGENCIES

In the event of an emergency specifically concerning **“Owner’s”** dog, **“Walker”** shall contact the Owner at the telephone number(s) provided to confirm **“Owner’s”** choice of action. If **“Owner”** cannot be reached in a timely manner, **“Walker”** is authorized to:

- • Transport the dog(s) to an emergency clinic if the previous two options are not feasible, and notify “Owner” at all contact options previously provided (telephone, email, text) as to the action taken.
- • Authorize an initial consultation / check-up with the emergency vet.

6. LIABILITY

6.1 “Walker” is fully insured relative to the services performed for “Owner”. A copy of the insurance can be made available to the “Owner” upon request.

6.2 “Walker” accepts no liability for any breach of security or loss of or damage to “Owner’s” property during the term of this agreement.

“Owner” shall be liable for all medical expenses and damages resulting from injury to “Walker” caused by “Owner’s” dog, as well as, any damage to “Owner’s” property.

6.4. “Walker” is released from any liability related to transporting “Owner’s” dog(s) to and from any veterinary clinic or kennel; the medical treatment of the “Owner’s” dog(s) and any expense thereof.

7. GENERAL

This Dog Walking Contract, and the attached Client Pet Profile Form constitute the sole and entire agreement between “Owner” and “Walker” (also referred to together as the “Parties” or individually, as either “Party.”

The “Parties” waive the right to rely on any alleged expressed or implied provision not contained therein. Any alteration to this agreement must be in writing and signed by both “Parties.”

This “Contract” and Agreement shall be construed, interpreted and governed in accordance with the governing laws of the State of California and should any provision of this contract be judged by an appropriate court invalid, it shall not affect any remaining provisions whatsoever.
